Directors' Report

The Directors have the pleasure to present the annual report and audited financial statements of Aurum Isis Institutional Dollar Fund Ltd. (the "Company" or the "Institutional Dollar Fund") for the year ended 31 December 2022 as set out herein in respect of matters required by the Bermuda Stock Exchange listing regulations.

Principal Material Changes

There have been no material changes in the objectives, strategies or key service providers of the Company during the year ended 31 December 2022.

Supplements in relation to the Company were issued on 8 February 2022 in order to satisfy requirements for offering Participating Shares to qualified investors in Switzerland.

Subsequent to the year ended 31 December 2022, Michael J Harvey resigned as a director of the Company and Kevin Insley was appointed a director of the Company effective 1 January 2023.

The Prospectus of Aurum Isis Fund Ltd. (the "Master Fund") and the supplements in relation to the Company were updated effective 1 January 2023. The Institutional Dollar Restricted and Unrestricted share classes were closed to new investment from 1 January 2023 except with the prior written consent of the Directors. Institutional Q and Professional AQ share classes were made available for investment incorporating quarterly liquidity terms. The updates also included Mr Insley's appointment along with a number of other general administrative amendments.

Shares of the Institutional Dollar Fund are denominated in US dollars. The Institutional Dollar Fund is one of five Feeder Funds (the "Feeder Funds") comprising the Institutional Dollar Fund, Aurum Isis Dollar Fund Ltd. (the "Dollar Fund"), Aurum Isis Swiss Franc Fund Ltd. (the "Swiss Franc Fund"), Aurum Isis Sterling Fund Ltd. (the "Sterling Fund") and Aurum Isis Euro Fund Ltd. (the "Euro Fund") that invest in the Master Fund. The Feeder Funds have US dollar, Swiss franc, sterling and euro denominated shares respectively. The Institutional Dollar Fund is listed on the Bermuda Stock Exchange.

The Feeder Funds must invest solely into Participating Shares of the Master Fund, except in the case of the Swiss Franc, Sterling and Euro Funds in respect of currency hedging. The Participating Shares of the Master Fund are valued in US dollars. The Swiss Franc, Sterling and Euro Funds whilst investing into US dollar denominated Participating Shares of the Master Fund will, by appropriate currency hedging, seek to protect the value of their shares in their respective currencies. The Master Fund pays the fees of the Administrators, Depositary, Audit, formation and minor out of pocket expenses and Directors' Fees of all Funds. Each Feeder Fund will otherwise bear its own costs and liabilities.

The Company's performance is allied with the performance of the Master Fund. The Performance Review, the Market Review and Outlook for the Master Fund for the year ended 31 December 2022, is contained within the annual report of the Master Fund, which is appended to the Company's financial statements.

Directors' Report (Continued)

Dividends

No dividends have been declared during the year ended 31 December 2022 (31 December 2021: US\$Nil) and the Directors do not recommend the payment of any dividends for the year ended 31 December 2022 (31 December 2021: US\$Nil).

Remuneration

The Directors are considered to be the only identified staff for the purposes of the European Union (Alternative Investment Fund Managers) Regulations 2013. The Directors are entitled to remuneration for their services from the Master Fund, please refer to the accompanying Master Fund financial statements for details of remuneration paid to the Directors.

Connected Parties

Transactions carried out with the Company by the Administrator, Bermuda Administrator, Investment Adviser, Depositary, Directors and other connected parties ("connected parties") must be carried out as if negotiated at arm's length. Transactions must be in the best interests of the Shareholders.

The Directors are satisfied all transactions with connected parties entered into during the year were conducted at arm's length prices.

Details of related parties and related party transactions are disclosed in note 7 – 'Related Parties' of the notes to the financial statements.

Environmental, Social and Governance ("ESG") and Sustainable Finance Disclosure Regulation ("SFDR")

The Directors, as part of the wider Aurum group, believe that environmental and social issues are important to any person or entity. There is a misconception that human beings, businesses and economic systems are separate from such issues and, therefore, incorporating these aspects is vital to sustainability and good governance. Details of the philosophy and the approach taken to ESG by the Directors, as part of the wider Aurum group, can be found at <https://www.aurum.com/environmental-and-social/>.

The Investment Adviser has determined that, in accordance with Article 6 of the SFDR, sustainable risk is not relevant for the Company. The Company, the Master Fund and the Investment Adviser pursue a multi-manager approach which manifests in a diversified portfolio of underlying hedge funds who in turn can hold thousands of positions traded intraday. It would not be feasible to monitor the number of underlying positions held in real-time, nor potentially influence which positions are held.

The investments underlying this financial product do not take into account the European Union ("EU") criteria for environmentally sustainable economic activities.

Independent Auditor's Report to the Shareholders of Aurum Isis Institutional Dollar Fund Ltd.

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Aurum Isis Institutional Dollar Fund Ltd. (the "Company") for the year ended 31 December 2022, which comprise the Statement of Comprehensive Income for the year ended 31 December 2022, the Statement of Financial Position as at 31 December 2022, the Statement of Cash Flows for the year then ended, and related notes, including the summary of significant accounting policies.

In our opinion, the financial statements present fairly, in all material respects, the financial position of the Company as at 31 December 2022, its financial performance and cash flows for the year then ended, in accordance with International Financial Reporting Standards ("IFRS").

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing ("ISAs"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the ethical requirements that are relevant to our audit of the financial statements in Bermuda, together with the International Ethics Standards Board for Accountants Code of Ethics for Professional Accountants ("IESBA Code"), and we have fulfilled our other ethical responsibilities in accordance with these requirements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Key Audit Matters

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Valuation of Investments at Fair Value \$818,132,523 (2021 - \$640,313,851)

Refer to note 2 ('Significant Accounting Policies') and to note 8 ('Financial Instruments and Risk Exposure').

The Key Audit Matter

Valuation of Investments at Fair Value

The Company is a Feeder Fund whose main investment is an investment into Aurum Isis Fund Ltd. (the "Master Fund").

The valuation of this investment is the key driver of the Company's net asset value and performance for the year. While the nature of the Company's investment does not require a significant level of judgement because the underlying value of the fund is observable, due to its significance in the context of the financial statements as a whole, valuation of the investment was identified as a risk of material misstatement which had the greatest effect on our overall audit strategy and allocation of resources in planning and completing our audit.

How the Matter was Addressed in Our Audit

Our audit procedures included, but were not limited to:

- *Obtained an understanding of the process in place for the valuation of the investment;*
- *Audited the Master Fund in accordance with ISAs and issued an unqualified audit opinion thereon;*
- *Assessed whether the Master Fund's net asset value was an appropriate approximation of fair value; and*
- *Considered the adequacy of the disclosure of investments made in the financial statements in relation to the fair value of investments and fair value disclosures for compliance with IFRS.*

We noted no material exceptions arising from our audit procedures.

Other Information

The Directors are responsible for the other information accompanying the financial statements. The information comprises the Director and Service Providers, the Directors' Report, the Portfolio Statement as at 31 December 2022 and the Supplementary Information (unaudited) and the Oath/Affirmation of the Commodity Pool Operator but does not include the financial statements and related notes, and Auditor's Report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion on that information.

Other Information (Continued)

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether that information is materially inconsistent with the financial statements or our knowledge obtained in the course of our audit, or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

We have nothing to report in this regard.

Respective Responsibilities and Restrictions on Use

Responsibilities of the Directors for the Financial Statements

The Directors are responsible for the preparation and fair presentation of the financial statements in accordance with IFRS, and for such internal control as the Directors determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Directors are responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Directors either intend to liquidate the Company or to cease operations, or have no realistic alternative but to do so.

The Directors are responsible for overseeing the Company's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Our report is made solely to the Company's Shareholders, as a body, in accordance with the terms of our engagement. Our audit work has been undertaken so that we might state to the Shareholders those matters we are required to state to them in an Auditor's Report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibilities to anyone other than the Company's Shareholders as a body, for our audit work, for this report, or for the opinions we have formed.

1. General

Aurum Isis Institutional Dollar Fund Ltd. (the "Institutional Dollar Fund" or the "Company") was incorporated in Bermuda on 27 January 2011 under the Bermuda Companies Act 1981 as amended and acts as an investment company.

The Company's investment objective is to achieve long term capital growth by investing in the Participating Shares of Aurum Isis Fund Ltd. (the "Master Fund"). The annual report and audited financial statements of the Master Fund for the year ended 31 December 2022 form an integral part of these financial statements and should therefore be read in conjunction with these financial statements.

The audited financial statements were approved by the Board of Directors on 20 March 2023.

2. Significant Accounting Policies

The significant accounting policies which have been applied are set out below.

Statement of Compliance

The financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standards Board ("IASB").

Basis of Preparation

The financial statements have been prepared on a historical cost basis except for financial instruments classified at fair value through profit or loss that have been measured at fair value.

The financial statements have been prepared on a going concern basis.

The functional currency of the Company is the US dollar as the Directors have determined that this reflects the Company's primary economic environment. The presentation currency of the financial statements is also the US dollar. All amounts have been rounded to the nearest US dollar.

New Standards and Interpretations Applicable to Future Reporting Periods

A number of standards and amendments to standards are effective for annual periods beginning after 1 January 2022 and earlier application is permitted. The Company has not early adopted them in preparing these financial statements, however, it is expected that they will have minimal effect on its financial statements.

The Directors have considered all the upcoming IASB standards and do not consider any to be of material relevance to the financial statements of the Company.

Financial Assets and Financial Liabilities

Recognition and Initial Measurement

Purchases and sales of investments are recognised on the trade date, the date on which the Company commits to purchase or sell the investment. Receivables are initially recognised when they are originated. All other financial assets and financial liabilities are initially recognised when the Company becomes a party to the contractual provisions of the instrument.

A financial asset or financial liability is initially measured at fair value plus, for an item not at fair value through profit or loss ("FVTPL"), transaction costs that are directly attributable to its acquisition or issue.

Classification and Subsequent Measurement of Financial Assets and Financial Liabilities

Financial Assets

On initial recognition, a financial asset is classified as measured at: amortised cost, at fair value through other comprehensive income ("FVTOCI") or at FVTPL.

The Company classifies its investments based on the contractual cash flow characteristics of the financial assets and the Company's business model.

A financial asset is measured at amortised cost if it meets both of the following conditions and is not designated as at FVTPL:

- The asset is held within a business model whose objective is to hold assets to collect contractual cashflows; and
- The contractual cash terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

A financial asset is measured at FVTOCI only if it meets both of the following conditions and is not designated as at FVTPL:

- The asset is held within a business model whose objective is achieved by both collecting contractual cashflows and selling financial assets; and
- The contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial Assets (Continued)

All other financial assets are classified as measured at FVTPL, this includes all derivative financial assets.

On initial recognition, the Company may irrevocably designate a financial asset that otherwise meets the requirements to be measured at amortised cost or at FVTOCI as at FVTPL if doing so eliminates or significantly reduces an accounting mismatch that would otherwise arise.

The Company's investment objective is to invest in the Master Fund, whose investment objective is achieved through capital appreciation arising from an actively managed portfolio of Investee Funds involving Investee Funds being purchased and sold based on an evaluation of their performance on a fair value basis. Each Investee Funds' objective is to provide a capital return rather than cash flow generation. This results in the Company's and the Master Fund's business model bifurcating between Investee Funds held and Other Financial Assets:

- Investee Funds held are classified as 'Investments at fair value' on the Statement of Financial Position because their performance is evaluated on a fair value basis.
- Other Financial Assets are included within 'Financial assets at amortised cost' on the Statement of Financial Position because the Company has classified them as 'Held to collect' in accordance with IFRS 9. Other Financial Assets include Investee Funds sold where the Company awaits receipt of cash proceeds from sale, cash paid to Investee Funds where the Company awaits receipt of units and other operating receivables and prepaid expenses.

Financial Assets at FVTPL

The Company holds the Master Fund at a fair value of US\$818,132,523 at 31 December 2022 (2021: US\$640,313,851). These securities are mandatorily classified as FVTPL, as the contractual cash flows are not solely principal and interest and therefore, are measured at FVTPL.

As such, the Company classifies all of its investment portfolio as financial assets at FVTPL.

Financial Assets at Amortised Cost

These include other receivables which are held for collection. These are recognised initially at fair value and subsequently measured at amortised cost using the effective Interest Rate Method, less provision for impairment. At each reporting date, the Company shall measure the loss allowance on amounts due from broker at an amount equal to the lifetime expected credit losses if the credit risk has increased significantly since initial recognition. If, at the reporting date, the credit risk has not increased significantly since initial recognition, the Company shall measure the loss allowance at an amount equal to 12-month expected credit losses, or shorter if the receivable is expected to settle in less than 12 months.

Significant increase in credit risk is defined by the Board of Directors as any contractual payment which is more than 30 days past due.

The Company considers a financial asset to be in default when the financial asset is more than 90 days past due.

Financial Liabilities

The Company classifies its financial liabilities other than derivatives, as measured at amortised cost. Derivatives, if any, not designated in a qualifying hedge relationship are mandatorily classified at FVTPL.

Offsetting

Financial assets and liabilities are offset and the net amount presented in the Statement of Financial Position when, and only when, the Company has a legal right to set off the recognised amounts and it intends to either settle on a net basis or to realise the asset and settle the liability simultaneously.

For the year ended 31 December 2022, and 31 December 2021, there were no financial assets or liabilities subject to enforceable master netting arrangements or similar agreements which would require disclosure.

Derecognition

A financial asset is derecognised when the Company loses control over the contractual rights that comprise that asset. This occurs when the rights are realised, they expire or they are surrendered. A financial liability is derecognised when the obligation specified in the contract is discharged, cancelled or it expires.

2. Significant Accounting Policies (Continued)

Participating Shares

Under IFRS, Participating Shares redeemable at the Shareholder's option are classified as financial liabilities and the format of the Statement of Financial Position reflects this in accordance with IAS 32 "Financial Instruments: Presentation". The net assets attributable to holders of Participating Shares are stated at the present value of the redemption amount on the reporting date without discounting, which are measure at amortised cost.

Sponsor Shares

Sponsor Shares are classified as equity based on the substance of the contractual arrangements between the Company and the Sponsor Shareholder and in accordance with the definition of equity instruments under IAS 32. The Sponsor Shareholder's equity is stated at original cost.

Translation of Foreign Currencies

Transactions in currencies other than US dollar are recorded at the rate prevailing on the date of the transaction. At each reporting date, non US dollar denominated monetary items and assets and liabilities measured at fair value are retranslated at the rate prevailing on the reporting date. Foreign currency exchange differences related to investments at fair value through profit or loss are included in Net gain on investments. All other differences are reflected in net profit or loss for the year.

Net Gain on Investments

Net gain on investments includes all realised and unrealised fair value changes and foreign exchange differences, but excludes interest.

Net realised gain on investments is calculated using the Average Cost Method.

Interest Income

Interest income is recognised in the Statement of Comprehensive Income for all interest bearing instruments on an effective interest rate yield basis.

Cash and Cash Equivalents and Bank Overdraft

Cash and cash equivalents comprise cash balances held at banks. Bank overdrafts are repayable on demand. In the Statement of Cash Flows, cash and cash equivalents are shown net of any short term overdrafts which are repayable on demand, and form an integral part of the Company's cash management.

Expenses

All expenses are recognised in the Statement of Comprehensive Income on an accruals basis.

Significant Accounting Judgements and Estimates

The preparation of financial statements in accordance with IFRS requires management to make judgements, estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the year. Actual results could differ from those estimates.

Revisions to accounting estimates are recognised in the year in which an estimate is revised.

The area of estimates which has the most significant effect on the amounts recognised in the financial statements is the valuation of investments which is disclosed within note 9 'Fair value measurement'.

Information about judgements made in applying accounting policies that have the most significant effects on the amounts recognised in the financial statements is included within 'Basis of preparation' above and note 8 'Financial instrument and risk exposure'.

Master Fund

The Master Fund is not considered to be a subsidiary of the Company as the Investment Adviser beneficially holds all general voting shares which give the holder the current ability to direct the activities that significantly affect the returns of both the Company and the Master Fund. IFRS 10 "Consolidated Financial Statements" single control model states that an entity has control over an investee when it is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee. The Directors are satisfied that the Master Fund does not meet the definition of a subsidiary in accordance with IFRS 10.

2. Significant Accounting Policies (Continued)

Structured Entities

A structured entity is an entity that has been designed so that voting or similar rights are not the dominant factor in deciding who controls the entity, such as when any voting rights relate to administrative tasks only and the relevant activities are directed by means of contractual arrangements. A structured entity often has some or all of the following features or attributes; restricted activities, a narrow and well-defined objective, such as to provide investment opportunities for investors by passing on risks and rewards associated with the assets of the structured entity to investors, insufficient equity to permit the structured entity to finance its activities without subordinated financial support and financing in the form of multiple contractually linked instruments to investors that create concentrations of credit or other risks.

The Company has determined that its investment in the Master Fund represents an investment in an unconsolidated structured entity. The Master Fund finances its operations by issuing redeemable shares which are puttable at the holders' option and entitle the holder to a proportional stake in the Master Fund's net assets. The change in fair value of the Company's holding in the Master Fund is included in the Statement of Comprehensive Income within Net gain on investments.

The Directors believe that the requirements of IFRS 12 "Disclosure of Interests in Other Entities", in relation to structured entities, are observed by appending the Master Fund's financial statements to the Company's financial statements.

3. Investment Adviser and Incentive Fees

The Company pays the Investment Adviser an annual percentage fee (the "Investment Adviser Fee") and a performance related fee in respect of each class of share where certain performance criteria have been met (the "Incentive Fee"). The Investment Adviser Fee is calculated monthly and paid monthly in arrears.

The Investment Adviser Fee is calculated based on a percentage of the Gross Asset Value of the Company as at the relevant month end. The Gross Asset Value means the value of the assets of the Company at a valuation point less the liabilities and accrued expenses of the Company other than liabilities that relate to Investment Adviser Fees, Incentive Fees, Administrator Fees, Depositary Fees, Directors' Fees, Audit Fees, Formation Expenses and Sundry Expenses each as incurred with respect to the valuation period ending on such valuation point.

Share classes not designated as LTI 3

The Incentive Fee is calculated and paid monthly in arrears and is equal to the number of Participating Shares in the relevant series multiplied by a percentage of the amount by which the Gross Asset Value per Participating Share on a valuation day exceeds the higher of:

- (i) The Base Value: the Net Asset Value per Participating Share on the Base Date increased by the relevant hurdle of 1/12 of the annualised hurdle rate multiplied by the number of incentive fee periods since the last Base Date. The Incentive Fee Period is the day following the last valuation day in the immediately preceding calendar month until the next valuation day. The Base Date is the last valuation day in the immediately preceding calendar year or, if later, the first valuation day in respect of a share class; or
- (ii) The High Water Mark: the Net Asset Value per Participating Share on the last valuation day upon which an Incentive Fee was crystallised or, if higher, the initial Net Asset Value per Participating Share upon inception of that share class.

Share classes designated as LTI 3

The Incentive Fee is calculated and paid annually in arrears and is equal to the number of Participating Shares in the relevant series multiplied by a percentage of the amount by which the Gross Asset Value per Participating Share on a valuation day exceeds the higher of:

- (i) The Base Value: the Net Asset Value per Participating Share on the Base Date increased by the relevant hurdle of the annual hurdle rate provided that where the Incentive Fee Period is not a full calendar year the hurdle in respect of such period shall be 1/12 of the annualised hurdle rate multiplied by the number of monthly valuation days in such Incentive Fee Period. The Incentive Fee Period in respect of each series of Shares is the day following the last valuation day in the immediately preceding calendar year until the last valuation day in the current calendar year, provided that the first Incentive Fee Period commences on the dealing day on which Shares in that series are issued and, where some or all Shares in the relevant series are redeemed before the last valuation day in the current calendar year, the Incentive Fee Period in respect of such Shares being redeemed shall end on the valuation day immediately preceding the relevant redemption day. The Base Date is the last valuation day in the immediately preceding calendar year or, if later, the first valuation day in respect of a share class; or
- (ii) The High Water Mark: the Net Asset Value per Participating Share on the last valuation day upon which an Incentive Fee was crystallised or, if higher, the initial Net Asset Value per Participating Share upon inception of that share class.

The capital of the Company is represented by the net assets attributable to holders of Participating Shares. The amount of net assets attributable to holders of Participating Shares can change significantly on a monthly basis, as the Company is subject to subscriptions and redemptions at the discretion of Shareholders, as well as changes resulting from the Company's performance. The objective when managing capital is to safeguard the ability to continue as a going concern in order to provide returns for Shareholders and maintain a strong capital base to support the development of the investment activities.

In order to maintain the capital structure, the policy is to perform the following:

- Monitor the level of subscriptions and redemptions relative to the assets it expects to be able to liquidate.
- Redeem and issue new Participating Shares in accordance with the constitutional documents.

The Board of Directors monitor capital on the basis of the value of net assets attributable to Participating Shareholders.

6. Bank Overdraft

The Company has banking facilities with The Northern Trust Company, an affiliate of the Administrator. The Northern Trust Company is entitled to interest ("Interest Charges") at an annual rate of 1.5% above the Northern Trust base rate of 3% (2021: -1.25%) on any overdrawn balances. The Interest Charges are incurred daily and are included in the Statement of Comprehensive Income within Finance costs.

7. Related Parties

In accordance with IAS 24 "Related Party Disclosures" the related parties of the Company are outlined below. Some parties, who are connected as a result of key contracts, also have significant proximity to the operations of the Company and so are also outlined below in order to comply with the substance of IAS 24.

The Company's related and connected parties include the Directors, the Administrator and its affiliates, the Bermuda Administrator, the Investment Adviser and the Depository. Principal amounts incurred during the year, and amounts due as at the Statement of Financial Position date, are clearly identified in the financial statements. Other amounts are outlined below.

Key Management Personnel

Mrs T Gibbons and Mr D Cottingham are Directors of the Investment Adviser. Mr A Hopkin and Mr K Insley are Directors of Continental Management Limited, the Secretary, Continental Sponsors Ltd., the sponsoring broker on the Bermuda Stock Exchange, Global Fund Services Ltd., the Bermuda Administrator and the Investment Adviser. Mr M Harvey was a Director of Continental Management Limited and Global Fund Services Ltd. up until 30 June 2022 and prior to his resignation, which was effective 1 January 2023, he was a Director of the Investment Advisor and indirectly held shares in the Investment Adviser. Mr K Gundle, Mr A Hopkin and Mr D R Cottingham also directly and indirectly hold shares in the Investment Adviser.

The Investment Adviser owns all of the Sponsor Shares of the Company. The Investment Adviser is also the sponsor, adviser and investment manager to a number of other investment companies and the Directors of the Company and the Investment Adviser may serve as Directors of such companies.

The Directors are entitled to remuneration for their services from the Master Fund, please refer to the accompanying Master Fund financial statements for details of remuneration paid to the Directors.

At 31 December 2022, Directors and persons so connected did not directly or indirectly hold Participating Shares in the Company (2021: Nil).

Other Key Contracts

The Company is related to the Master Fund through common Directors having significant influence over the combined operations of the Feeder Funds and the Master Fund. The value of the Company's investment in the Master Fund is presented in the Statement of Financial Position as 'Investments at fair value', transactions between the Company and the Master Fund during the year are outlined in note 8 'Financial instruments and risk exposure'.

Gains and losses from IPOs for the year of US\$97,461 (2021: US\$2,923,670) have been recorded on the Statement of Comprehensive Income within 'Net gains on investments'. At 31 December 2022, US\$17,568 was due from (2021: US\$18,035 due to) the Master Fund for the Company's Unrestricted Income Allocation and has been included within 'Other receivables' (2021: 'Other payables') on the Statement of Financial Position. The total gain for 2022 was settled monthly in arrears by an in-specie issue of a total of 199.8913 shares (2021: 6,552.3230 shares) of the Master Fund using the net asset value per share reported by the administrator of the Master Fund at each month end. 34.2942 of those shares were issued in January 2023 to settle the US\$17,568 due to the Company at 31 December 2022 (2021: 39.2382 shares redeemed in January 2022 to settle US\$18,035 due from the Company).

Please refer to the accompanying Master Fund financial statements for details related to Other Key Contracts.

Banking facilities are supplied by an affiliate of the Administrator, as outlined above. Interest Charges in relation to the bank overdraft are included in the Statement of Comprehensive Income recorded within 'Finance Costs'.

8. Financial Instruments and Risk Exposure

The Company invests all its assets into the Master Fund which is exposed to market risk, credit risk and liquidity risk arising from the financial instruments it holds. These risks are explained in the financial statements of the Master Fund which are attached. Financial instruments include investments, cash and cash equivalents, subscriptions to shares not yet allotted, accrued expenses and Participating Shares presented as financial liabilities.

The Master Fund and the Feeder Funds operate as an integrated structure whereby the Feeder Funds invest solely into the Master Fund except in respect of currency hedging. Total subscriptions made by the Company into the Master Fund during the year were US\$117,471,804 (2021: US\$272,392,077) and total redemptions made by the Company out of the Master Fund during the year were US\$19,320,993 (2021: US\$5,699,841).

Investments in the Master Fund are recorded at the Net Asset Value per Share as reported by the Administrator of the Master Fund at the measurement date. Where the Administrator is unable to provide Net Asset Value per Share, the Directors make their own assessment of value based on available information. In determining fair value, the Directors take into consideration, where applicable, the impact of suspensions of redemptions, liquidation proceedings, investments in side pockets and any other significant factors.

At 31 December 2022, and 31 December 2021, there were no instances wherein the Administrator was unable to provide the Net Asset Value per Share or that the Directors considered it necessary to make any adjustment to the Net Asset Value per Share provided in order to arrive at fair value.

8. Financial Instruments and Risk Exposure (Continued)

As at 31 December 2022, and 31 December 2021, the Company had no capital commitment obligations and no amounts were due from the Company for unsettled purchases. The Company invests into the Master Fund by purchasing the Master Fund's redeemable Participating Shares. The Master Fund allows redemption of these shares on a monthly basis with a three month notification period. Movements in the fair value of the Master Fund's portfolio and corresponding movements in the fair value of the Company expose the Company to a profit or loss.

Cash and cash equivalents and bank overdrafts, are held with the Depository. The Depository is a wholly owned subsidiary of Northern Trust Corporation that had a Long Term Rating from Standard and Poors of A+ at 31 December 2022 (31 December 2021: A+).

Liquidity Risk

The following tables show the contractual undiscounted cash flows of the Company's financial liabilities on the basis of the earliest possible maturity. Participating Shares may be redeemed on a monthly basis subject to prior notice which differs between the share classes and ranges from 90 days to 3 years.

Leverage

The Master Fund and the Feeder Funds may use overall leverage up to a maximum of 30% of the Master Fund's and the Feeder Funds' total assets, without double counting, from time to time for general investment purposes or to facilitate redemptions.

During the year the maximum leverage utilised by the Company, measured at any one month end, was less than 1% (2021: less than 1%). Please refer to the Master Fund financial statements for details of the maximum leverage utilised by the Master Fund.

9. Fair Value Measurement

The fair value hierarchy prioritises the inputs to valuation techniques used to measure fair value. The categorisation of assets and liabilities within the hierarchy is explained in note 9 of the Master Fund's notes to the financial statements.

The fair value of investments in the Master Fund is determined using the unadjusted Net Asset Value (Level 2 valuation). The unadjusted Net Asset Value is used because the units in the Master Fund are redeemable at the reportable Net Asset Value at, or approximately at, the measurement date. If this were not to be the case, then the Net Asset Value would be used as a valuation input and an adjustment applied for lack of marketability or liquidity generally based on available market information (Level 3 valuation). Any adjustment would be based on management judgement after considering the period of restrictions and the nature of the Master Fund.

For the year ended 31 December 2022, and 31 December 2021, all other assets and liabilities, other than investments at fair value, whose carrying amounts approximate fair value would have been considered to be classified within Level 2 of the fair value hierarchy if such classification was required.

The Company redeems and issues redeemable Participating Shares at the amount equal to the proportionate share of net assets of the Company at the time of subscription or redemption, calculated on a basis consistent with that used in the financial statements. Accordingly, the carrying amount of net assets attributable to holders of Participating Shares approximates their fair value. The shares are categorised into Level 2 of the fair value hierarchy.

10. Movement on Investments

Gains and losses related to investments are recognised in the Statement of Comprehensive Income within Net gain on investments. The net gain comprises unrealised gains and losses reflecting the movement in the fair value of investments held at the 31 December 2022 and realised gains and losses related to investments sold during the year. The Net gain on investments for the year includes the Company's allocation of unrestricted income of US\$97,461 (2021: US\$2,923,670), such gains, or losses, are solely attributed to unrestricted Participating Shareholders. 11. Taxation

The Company has received an undertaking from the Ministry of Finance of Bermuda, under the Exempted Undertakings Tax Protection Act, 1966 exempting the Company from Bermuda income, profit, capital transfer or capital taxes, should such taxes be enacted, until 31 March 2035.

12. Subsequent Events

Subsequent to the year ended 31 December 2022, Michael J Harvey resigned as a director of the Company and Kevin Insley was appointed a director of the Company effective 1 January 2023.

12. Subsequent Events (Continued)

The Prospectus of the Master Fund and the supplements in relation to the Company were updated effective 1 January 2023. The Institutional Dollar Restricted and Unrestricted Share Classes were closed to new investment from 1 January 2023 except with the prior written consent of the Directors. Institutional Q and Professional AQ Share Classes were made available for investment incorporating quarterly liquidity terms. The updates also included Mr Insley's appointment along with a number of other general administrative amendments.

No other events have occurred in respect of the Company subsequent to 31 December 2022 which would require revision or disclosure in these financial statements.

Supplementary Information (unaudited)

The following information is provided pursuant to an exemption claimed under Rule 4.7 of the Commodity Futures Trading Commission.

The Company's investment in the Master Fund represents 100% of its investment portfolio. The income received by the Company from its investment in the Master Fund is presented as 'Net gain on investments' on page 8. The Master Fund does not charge any Management Fees or Incentive Fees in relation to the Company's investment. The income applicable to each class of Participating Shares after fees paid by the Company is presented in note 5 'Share Capital and Net Asset Value per Participating Share', those fees paid by the Company in relation to each share class are explained in note 3 'Investment adviser and incentive fees'.
