The Directors of the Company are pleased to announce that a distribution representing 27.66% of the Company’s Net Asset Value as at 31 December 2024 will be distributed to shareholders by means of a redemption of the Company’s A Class Ordinary Shares (“A Shares”) and B Class Ordinary Shares (“B Shares”).

The excess accumulated capital held by the Company has been the result of non-recallable distributions from the underlying investments of the Company.

Accordingly, payment of USD20,354,944.61 aggregate is expected to be paid to shareholders within the first two weeks of May 2025. A Class shares will be repurchased at a price of USD1,414.380 per share and B Class shares at a price of USD1,433.792 per share. A total of 14,332,660 shares will be redeemed by the Company, pro rata against each shareholders’ holding of A Shares and B Shares and cancelled thereafter.

Following the redemption, the Company’s issued share capital will be 37,489.465 of which 26,290.404 will be A Shares and 11,199.061 will be B Shares.

Further announcements will be made when further distributions are to be made to shareholders.
