**PIE Ratio**  
 PIE Ratio is calculated by dividing the current market price by the company's 12 month earnings per share (As shown in the latest published accounts).

**Price/Book**  
 Price/Book Ratio is calculated by dividing the current market price by book value per share.

**Div Amount**  
 Dividend is the amount of money distributed to shareholders by a company.

**Yield**  
 Yield is the current dividend or interest a stock or bond will earn, with the yield expressed as a percentage of the amount paid for the security or of the security's par value.

**Mkt Cap**  
 Market Capitalisation is determined by multiplying the number of outstanding shares by the current market price.
